The Author retains the copyright for the Article/Review and this is acknowledged in the copyright line on your Article/Review. The Author asserts the moral right to be identified as the Author of the Article/Review.

Public License

1. The Author and the Journal Editor agree that the Author grants an Attribution-Noncommercial-No Derivative Works 3.0 Unported Creative Commons License in the Article/Review to the general public (see <http://creativecommons.org/licenses/by-nc-nd/3.0/>). This means that the article may be copied, distributed, displayed, and performed under the following conditions:

- Attribution: credit must be given to the original author.
- Non-Commercial: no use for commercial purposes.
- No Derivative Works: the text may not be altered, transformed, or used to build upon.

2. The Author grants to the Publisher a royalty-free, worldwide, non-exclusive license to publish, reproduce, display, distribute and use the Article/Review in any form, either separately or as part of a collective work, including (but not limited to) a non-exclusive license to publish the article in an issue of the Journal, authorize reproduction of the entire Article/Review in another publication, and authorize reproduction and distribution of the Article/Review by means of computerized retrieval systems. The Author retains the ownership of all rights under copyright in the Article, and all rights not expressly granted in this Agreement.

3. The Author agrees that the Journal be given credit as the original publisher in any republication of the Article/Review authorized by the Author. If the Editor authorizes any other party to republish the article under the terms above, the Editor shall require such party to ensure that the Author is properly credited.

Editing

The Author agrees that the Journal Editors may edit the Article/Review as suitable for publication in the Journal. The Editors agrees to publish the Article/Review subject to the

understanding that the Article/Review will not be published in the Journal unless, in its final form, it is acceptable to both the Author and the Editors.

Warranties

The Author represents and warrants that the Author has full power and authority to enter into this Agreement and to grant the licenses granted in this Agreement.

The Author represents and warrants that the Article/Review furnished to the Publisher has not been published previously. The Author warrants that, where illustrations are provided by the Author, the relevant permissions have been obtained (where applicable).

The Author represents and warrants that to the best of the Author's knowledge the Article/Review is not obscene, does not defame any person, does not invade the privacy of any person, and does not in any other manner infringe upon the rights of any person.
